WORSHIPCAST STREAMING LICENSE

GRANT OF LICENSE. You are being granted a non-exclusive, non-transferable license to publicly perform within the United States any "Musical Composition" controlled by one or more of the domestic Performing Rights Organizations (ASCAP, BMI and SESAC). Your right to publicly perform such musical compositions is limited to Content Platforms expressly approved by CCS and/or each applicable Performing Rights Organization. "Content Platforms" means the Internet website, including all its associated pages and subdomains, owned, operated and served by you, and/or mobile and/or desktop software applications, packages or bundles owned and controlled, directly or indirectly, by you and through which you make the musical compositions described herein available to your users. At all times, with or without notice to you, the rights granted to you hereunder shall be subject to rights granted to CCS by each applicable Performing Rights Organization, which may be modified from time to time.

LIMITATION ON RIGHTS. This WorshipCast Streaming License does not grant you the right to publicly perform dramatico-musical works, or any dramatic rights; nor does it grant you the right to reproduce, distribute, make available for download, and/or exercise any other right held by a copyright owner, or enable others to do so. This WorshipCast Streaming License does not cover performances of sound recordings (see below). All rights not expressly granted herein are reserved.

LICENSE LIMITATIONS. In order to qualify for this WorshipCast Streaming License, your organization must be a religious entity that (a) is exempt from taxes pursuant to 26 U.S.C. Section 501(c)(3) and (b) maintains one or more physical premises in the Territory at which such entity conducts worship or other religious services.

You are not authorized to perform publicly the Musical Compositions in connection with or via a Licensed Service that generates commercial revenues in connection with the Licensed Service in order to access the Content made available through such Licensed Service. You may generate revenues through your platform if the generation of such revenues are not connected directly to making available of Music Works through your platform; (e.g., merchandise sales, optional donation click-buttons, etc.) "Revenue" as used above, does not include online giving and/or the sale of goods, but includes all other revenue arising from the Content Platform(s).

You shall not exceed 1,476,000 sessions in an applicable calendar year. In the event total sessions exceeds 1,476,000, you shall report it to CCS and an additional fee shall be required. "Sessions" means a single, continuous period of access to an applicable License Service by an Authorized End User, regardless of the length of such period.

In the event CCS and/or any applicable Performing Rights Organization reasonably determine that you may exceed the foregoing License Limitations, your access may be suspended and/or denied, as the case may be, and/or you may be charged an additional fee. Actual use in excess of the License Limitations may result in automatic termination of this License.

URL/CONTENT PLATFORM APPROVAL. Prior to activation of any WorshipCast Streaming License, you shall provide CCS and/ or any applicable PRO with any and all requested information, which may include, but is not limited to, contact information, URL information, software application information, and advance review of your anticipated disseminating web site(s)/software application(s) (each, a "Content Platform"). CCS and/or any applicable PRO may deny your request for a WorshipCast Streaming License for any reason.

ACTIVATION FEE AND ANNUAL LICENSE FEE. You shall pay the applicable activation fee in addition to the applicable annual license fee set forth in the following chart. The activation fee and annual license fee is due and payable prior to activation of your WorshipCast Streaming License, and the annual license fee is due immediately prior to each renewal period. The determination of "Average Annual Member Size" shall be determined by calculating the average attendance during the preceding calendar year at all weekend services held at all of your physical church or organization premises in the aggregate. For purposes of clarification only, if a church has a weekly service during a one-year period, the church will add up attendance at each weekly service, then divide the total number by 52 (the number of weeks in one year). The annual license fee may be increased, in CCS's sole discretion, if your musical composition use substantially deviates from the average musical composition use by other similarly situated licensees. This annual license fee includes payments to be made to applicable Performing Rights Organizations. You



shall notify CCS in the event your average annual congregation size has changed prior to each renewal. Note: Public Performances of Musical Compositions under this WorshipCast Streaming License in excess of the License Limitations stated above may result in substantially increased License Fees. You are responsible for informing CCS if your Musical Composition use is at or near any License Limitations. CCS is not responsible for Licensee Fee increases due to any activities in excess of the License Limitations set forth herein.

CCS agrees to make payment on your behalf to applicable Performing Rights Organizations hereunder for this WorshipCast Streaming License; provided, however, CCS is not liable for any fees, royalties or other payments you are obligated to pay as a result of this WorshipCast Streaming License or any other agreement or obligation.

TERM AND TERMINATION. The term of this WorshipCast Streaming License shall commence upon activation and continue for a period of one (1) year. This WorshipCast Streaming License shall automatically renew, upon payment of the annual license fee by you, for successive one (1) year periods following the initial term. This WorshipCast Streaming License may be terminated by either party at any time upon written notice; provided, however, in the event you terminate this WorshipCast Streaming License without cause, you shall forfeit any activation fee and/or annual license fee(s) already paid to CCS.

You shall deliver electronic reports on a calendar quarterly basis to CCS which shall include (at minimum) the following information: (1) the originating URL(s) and/or software application(s); (2) the musical composition title; (3) the name of the songwriter(s) or composer(s), (4) the method of transmission (e.g., on-demand, Podcast, etc.); and (5) number of transmissions/ times the musical composition was performed. Notwithstanding the foregoing, CCS may, directly or on behalf of any applicable Performing Rights Organization and/or other interested third parties, from time to time, request that you deliver a musical composition use report containing the same or similar information.

LIMITATION OF LIABILITY. IN NO EVENT SHALL CCS BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY DAMAGES, INCLUDING, BUT NOT LIMITED TO, INCIDENTAL OR CONSEQUENTIAL DAMAGES (INCLUDING, WITHOUT LIMITATION, INDIRECT, SPECIAL, PUNITIVE, OR EXEMPLARY DAMAGES FOR LOSS OF BUSINESS, LOSS OF PROFITS, LOSS OF GOODWILL OR BUSINESS REPUTATION, BUSINESS INTERRUPTION, LOSS OF DATA, OR LOSS OF BUSINESS INFORMATION) ARISING OUT OF OR CONNECTED IN ANY WAY WITH THIS WORSHIPCAST STREAMING LICENSE, OR FOR ANY CLAIM BY ANY THIRD PARTY (INCLUDING FOR INTELLECTUAL PROPERTY INFRINGEMENT), EVEN IF CCS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
